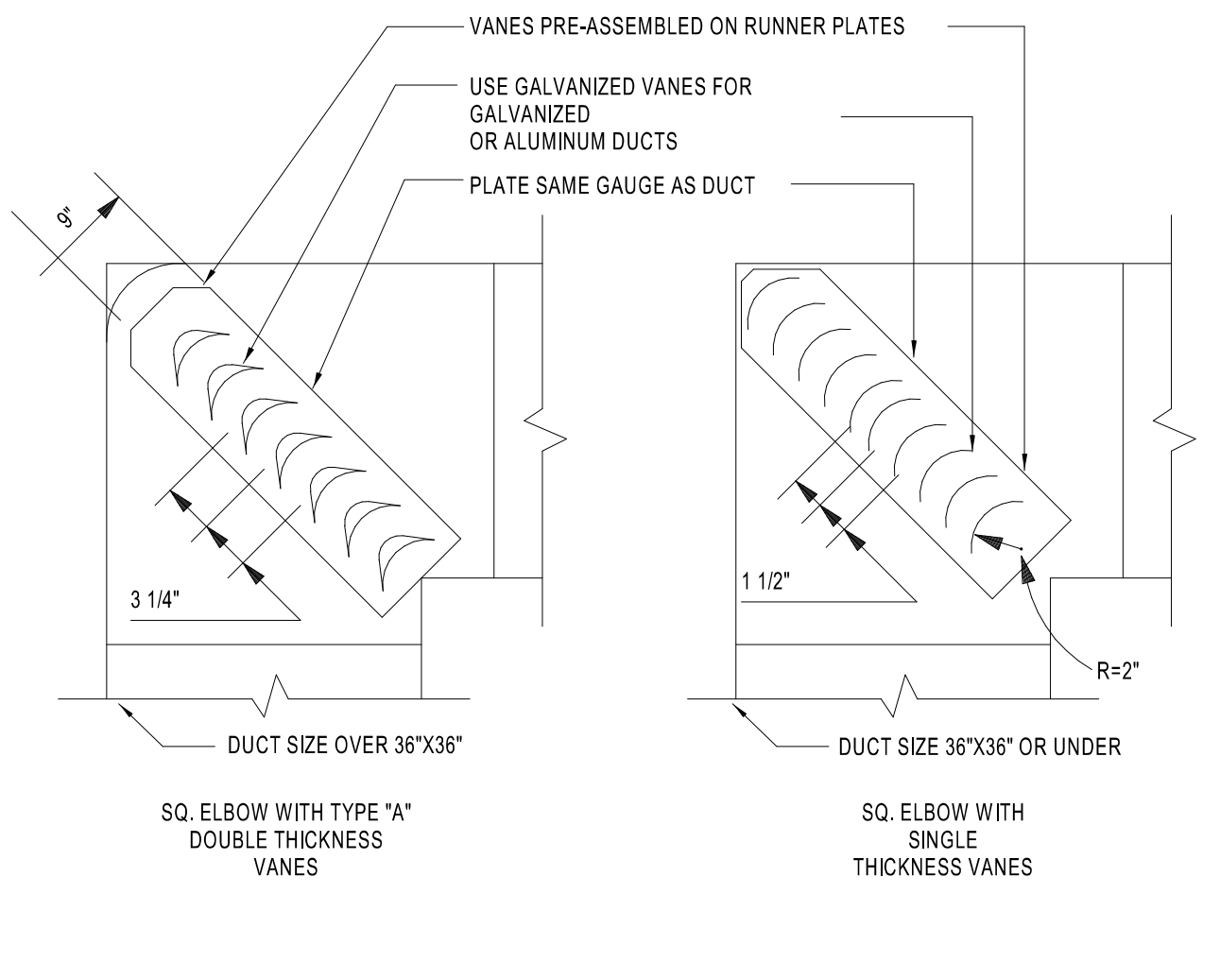

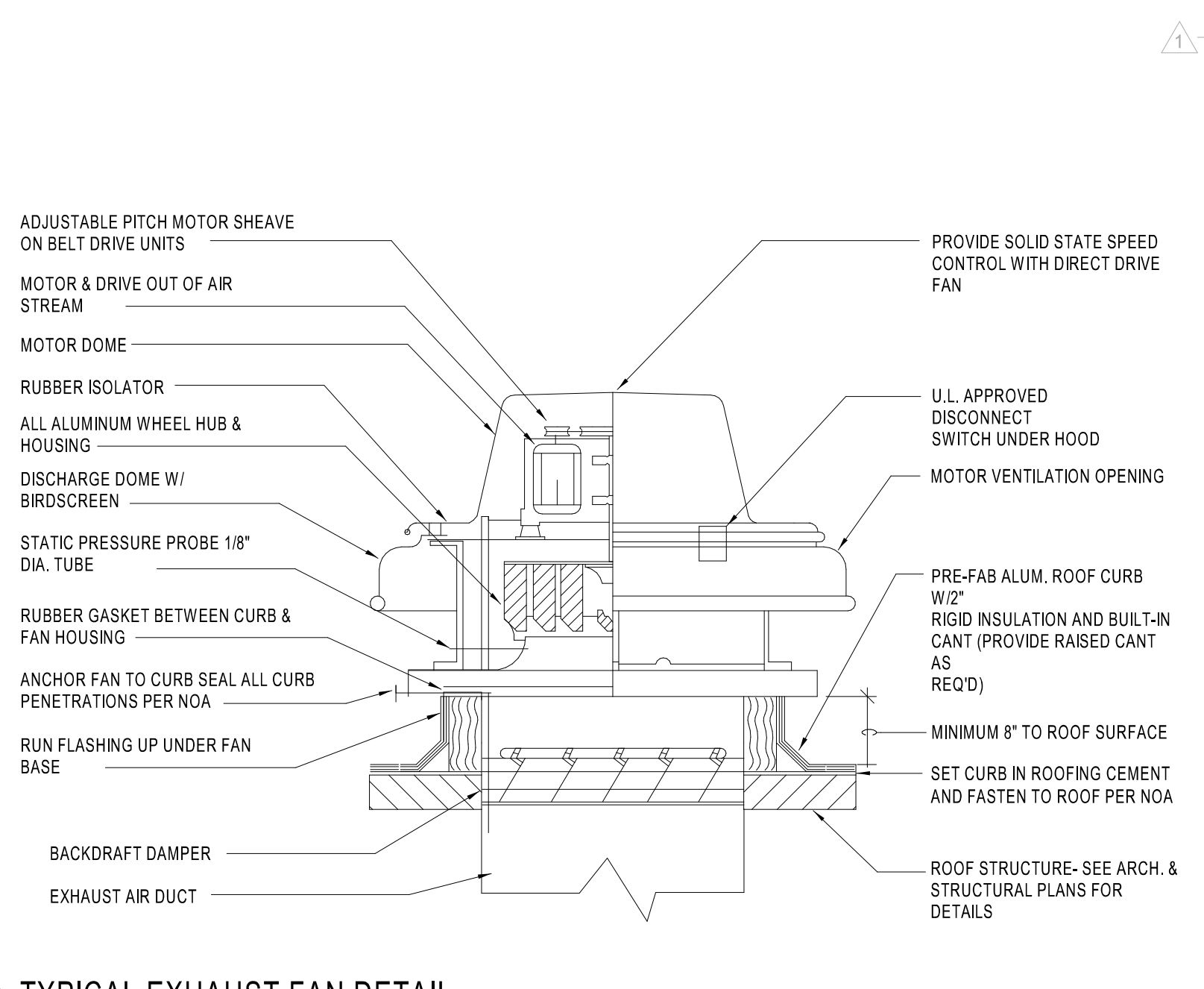
5 ROOF TOP UNIT MOUNTING DETAIL

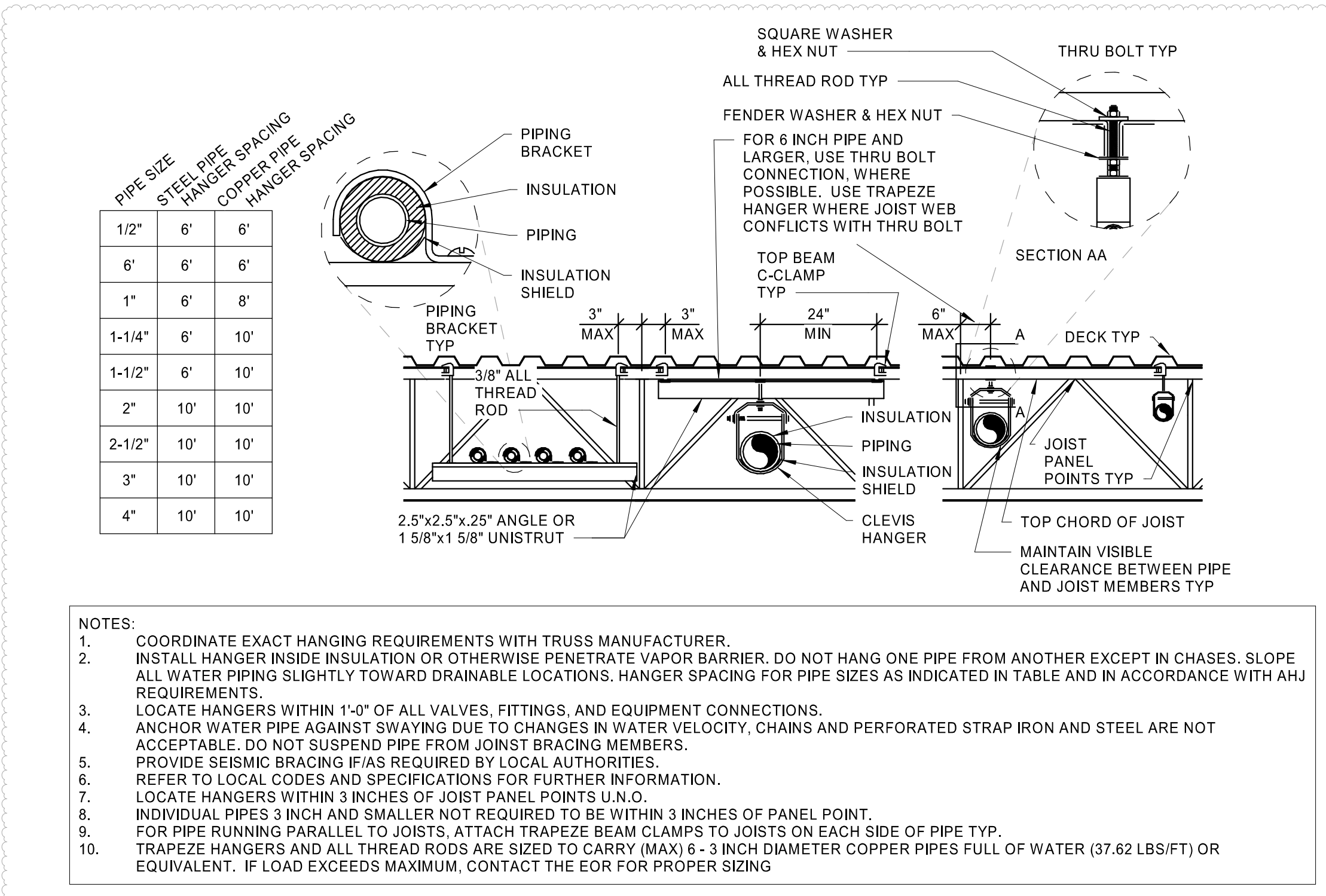
6 CO2 ALARM SYSTEM DETAIL

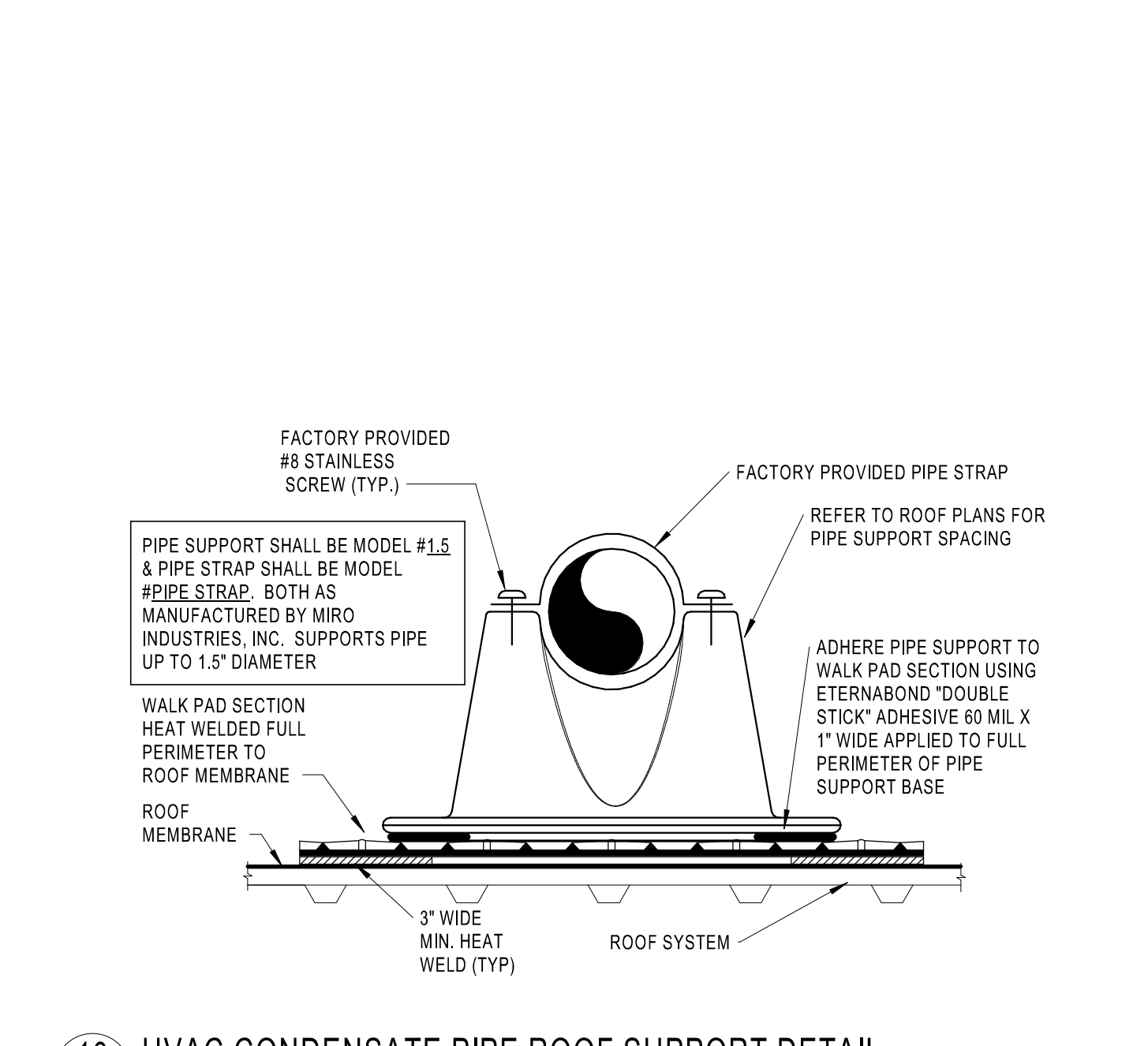
7 CEILING EXHAUST FAN DETAIL

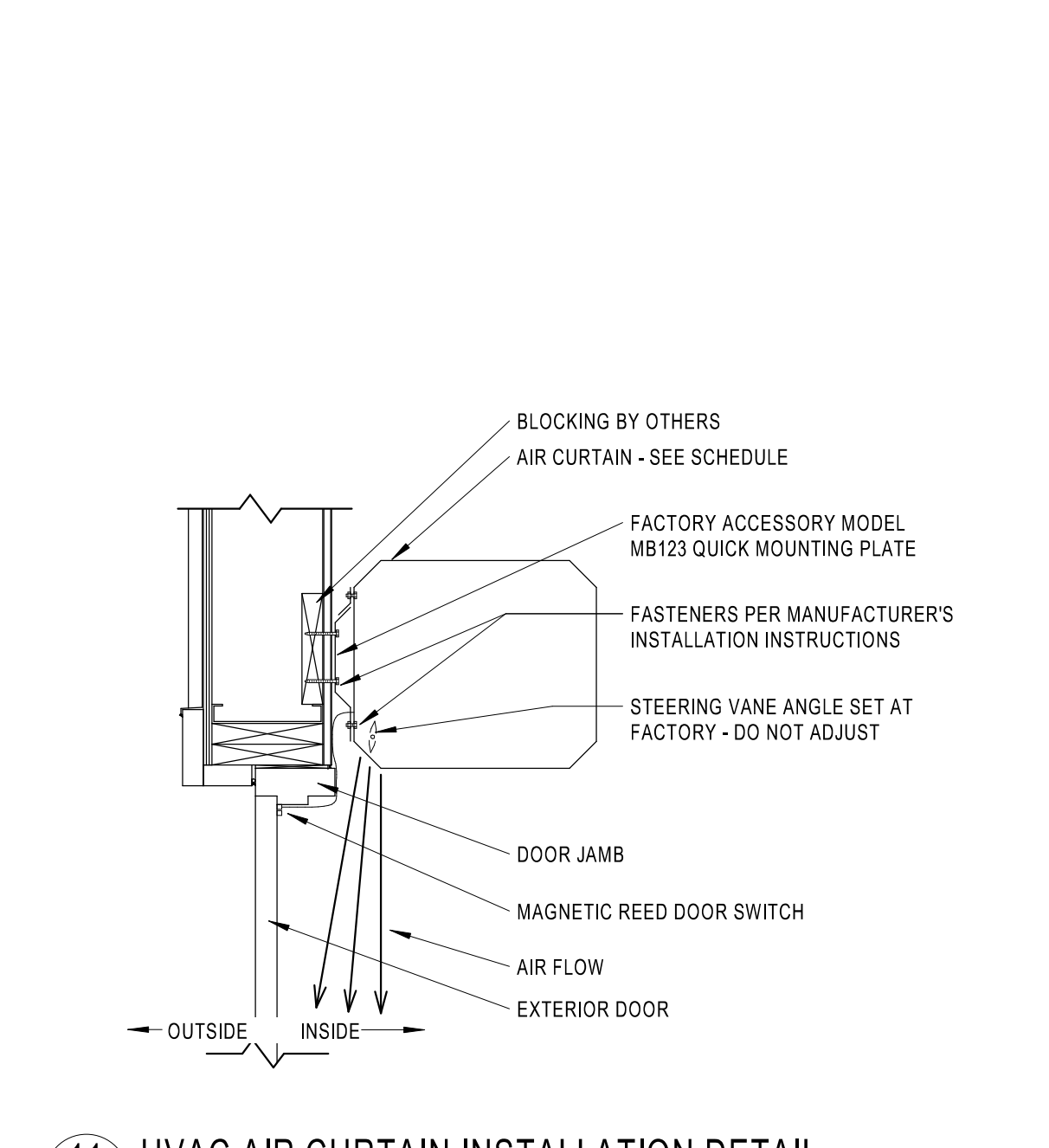
8 TYPICAL EXHAUST FAN DETAIL

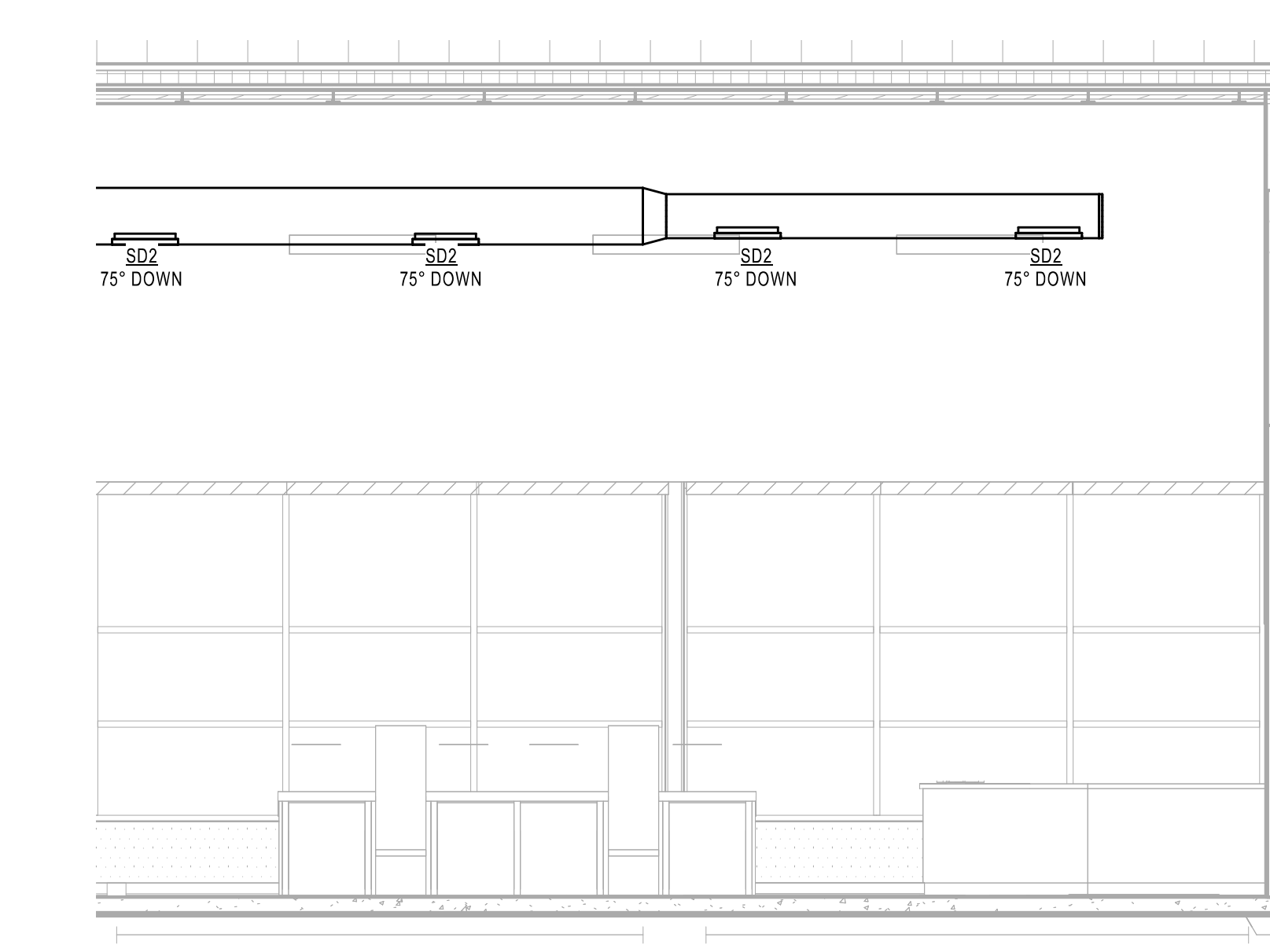
9 PIPE HANGER FOR STEEL JOIST DETAIL

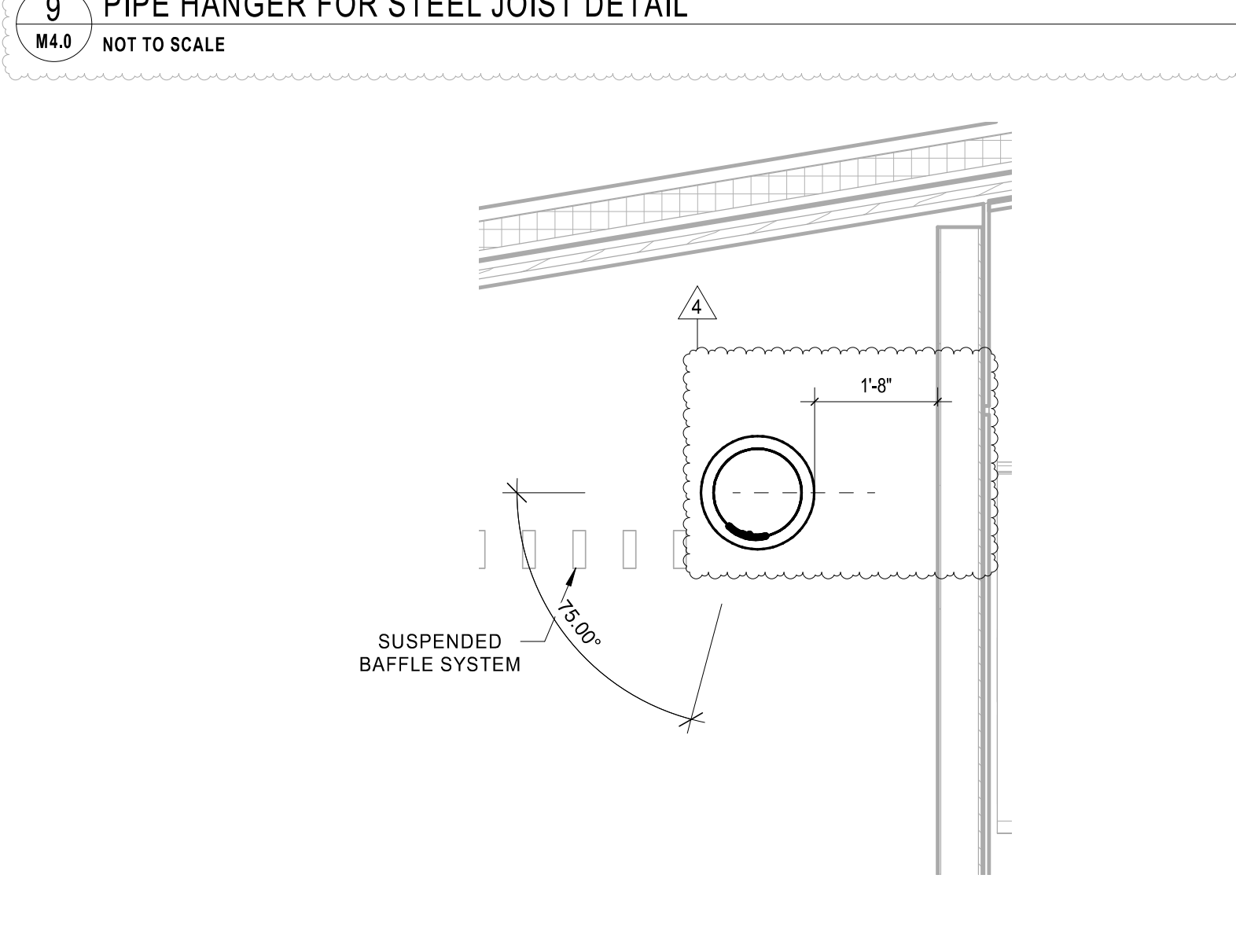
10 HVAC CONDENSATE PIPE ROOF SUPPORT DETAIL

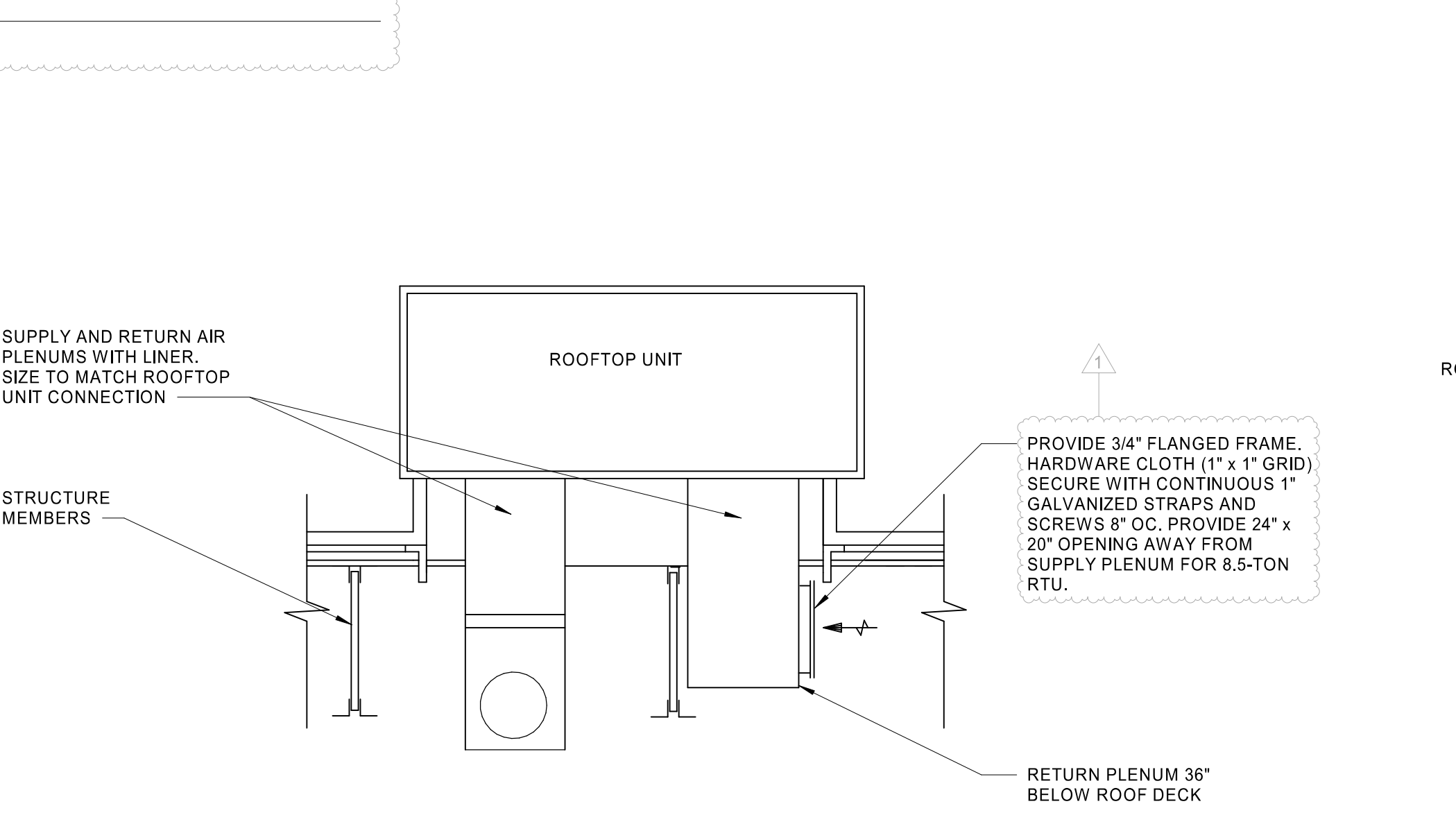
11 HVAC AIR CURTAIN INSTALLATION DETAIL

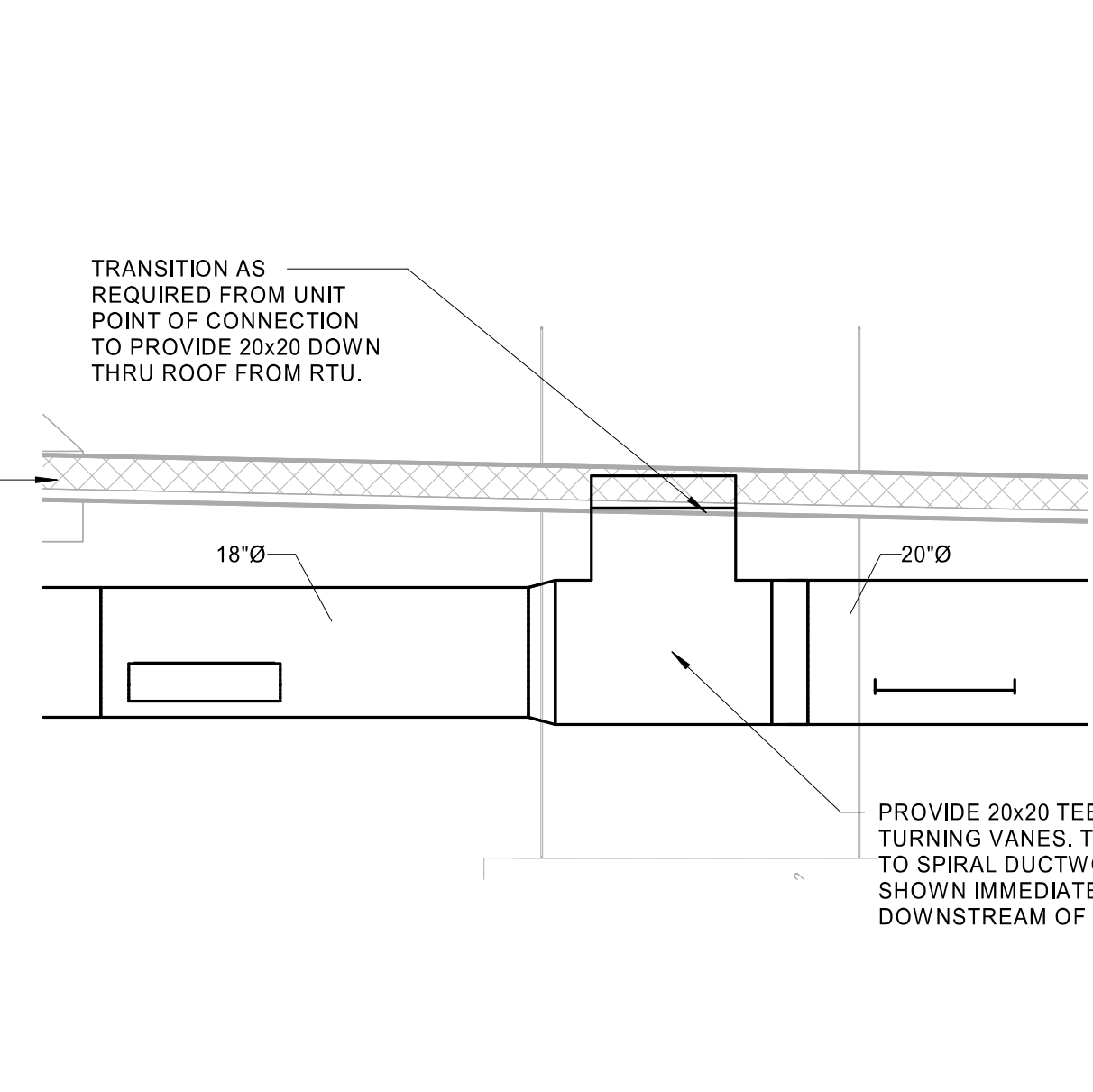
12 FRONT RETAIL DIFFUSER LAYOUT
